**Final provisions:**

- a) Value added tax is included in the prices for luggage storage, station services, seat reservation, seat pre-booking, use of the public announcement system, soiling of surfaces, printing of digital tickets, use of parking space (with permission), issuing confirmations of prices and timetables, the sale of timetables, subsidized transport application form, photocopies, sleeves, toilet tokens and information provided over phone by the call centre.
- b) Value added tax is not included in the prices of fees, use of parking space (without permission) and commissions for sold tickets and manipulative costs in case of purchase order cancellation.
